# President's Message

This past year the primary focus of the PLIA was to step up the fight against the milfoil growing in South Channel. We were optimistic that the State divers were able to eradicate it in the fall of 2015, but there were still roots that survived the winter and grew during the summer along with fragments creating new areas of growth. As we approached the 4<sup>th</sup> of July weekend, the Board made the hard decision to split the Boat Parade in two to avoid going through the channel. Signs were posted at each end of the channel and the State Park staff spoke with each camper as they registered asking that boaters avoid going through the channel. Marine Patrol also put up No Wake buoys and indicated that they would step up patrols in that area. My thanks to all who avoided South Channel through our time of crisis. The reduced traffic helped prevent the fragile plant from breaking off and rooting in other spots.

On the prevention side, a sizeable donation from a member allowed us to add a part-time Lake Host at the State Park along with focusing volunteer hours at the Park. The Fundy boat launch is staffed with paid Lake Hosts from Memorial Day through Labor Day, and this year a paid Host will also be at the State Park Friday, Saturday, and Sunday during that same



time. Volunteers will need to staff additional hours before Memorial Day and after Labor Day. Please consider becoming a volunteer in this very important program. (continued on p.3)

### Weed Watchers' & Milfoil Report

Last year Weed Watchers had their most active year. On May 14, 2016, Therese Thompson and Dee Decker conducted a training for both Weed Watchers and Lake Hosts at Nottingham's Municipal Building.



In addition to patrolling the entire lake along its shoreline, Weed Watcher volunteers personally informed residents of Shore Road along the South Channel about the milfoil infestation to enlist their cooperation and help.

Last year for the first time, PLIA volunteer Neil Santos formed a snorkel patrol. They regularly scan the known areas of milfoil infestation and beyond, mark newly discovered growths or regrowths, and alert the team of trained divers from NHDES in advance of their planned visits. This strategy takes advantage of local talent and creates an efficient plan of patrolling, diving, and removing. It also warns boaters to avoid these areas.

According to Amy Smagula, chief limnologist at NHDES who has helped us create a milfoil management plan, "The Pawtuckaway Lake milfoil growth is evolving, and fortunately there have been some good Weed Watching efforts and good responsiveness by divers to get in the lake and remove what is found, shortly after it is found. At this stage, the recommendations that I have are not much different from what is being done." We remain optimistic but alert.

Weed Watchers also investigated invasive weed growths near the Town beach, removed Purple Loosestrife from Horse Island, and pulled Phragmites in the usual areas.

### **Lake Host Boat Inspections**

2016 was a very busy year for the Lake Host Program. Not only did we expand our paid Hosts to the State Park but our volunteers inspected many boats as well. Our paid Hosts worked a total of 874 hours and our volunteers 334. We did 5535 courtesy inspections at the Fundy launch and 348 at the State Park. We had one save, variable milfoil.

In 2017 we plan to again increase the number of hours we have a paid Host at the Park, this year inspecting boats right after the toll booth. Park Manager Dave Richardson is very open to helping and again plans to include us as part of his staff's orientation training.

Paid Lake Hosts are funded through a grant from the NH Lakes Association, a town Warrant Article, and dollars collected from Membership to the PLIA. The 2017 grant has been submitted and the Town voted once again to fund the Lake Host Program as well as to set aside funds for future use fighting invasive species.

Please let us know if you would like training as a Lake Host, even for your own association or personal boat launch.



## **Pawtuckaway Loons**

Last summer a "successor" female loon appeared in the south end of the lake. She and her mate spent the summer getting acquainted but they did not nest—maybe in 2017! The north end pair successfully hatched two chicks as usual, both of which migrated in the fall after being lovingly monitored all season. During the annual loon census organized throughout NH by the Loon Preservation Committee in mid-July, several Pawtuckaway volunteers counted a record number of 9 adults and 2 chicks.

Prevention is our best defense against exotic species! You can be part of these crucial efforts! 
